Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$114,463,481 as of December 31, 2024, compared to \$106,290,580 as of January 1, 2024. During the plan year the plan experienced an increase or (decrease) in its net assets of \$8,172,901. This increase or (decrease) includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$148,675,643 including employer contributions of \$92,484,161, employee contributions of \$40,043,579, realized gains or (losses) of \$0 from the sale of assets, and earnings from investments of \$9,224,265.

Plan expenses were \$140,502,742. These expenses included \$11,850,825 in administrative expenses, \$128,651,917 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
